Coca-Cola's Race Team Sweepstakes Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

- Eligibility: The Coca-Cola's Race Team Sweepstakes (the "Sweepstakes") is open only to legal residents of Arizona who are eighteen (18) years of age or older at the time of entry. - **4. Promotion Period:** The Sweepstakes begins at 12:00 a.m. Mountain Standard Time ("MST"), September 2, 2020 and ends at 11:59 p.m. MST, October 23, 2020 (the "Promotion Period"). Administrator's computer and Circle K's computer are the official time-keeping devices for this Sweepstakes, depending on method of entry.

Your purchase will prompt the digital screen located at the register with instructions on how to enter. You may enter the Sweepstakes by entering your mobile phone number on the Lift touchscreen. Once you have successfully done so, you will automatically receive one (1) entry into the Sweepstakes, up to the limit stated below.
 - b. Free Online Method of Entry: During the Promotion Period, to enter without making a purchase or visiting a Circle K location, visit www.cokeplaytowin.com/circlekracingsweeps and follow the links and instructions to complete and submit the registration form, including providing a valid home address. P.O. Boxes are not permitted. You automatically will receive one (1) entry into the Sweepstakes, up to the limit stated below.

<u>Limit</u>: one (1) Sweepstakes entry per person per day during the Promotion Period, regardless of method or combination of methods of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses,

identities, registrations or logins, or any other methods will void that entrant's entries and that entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holders.

- 6. **Drawings:** Administrator is an independent judging organization whose decisions as to the selection of the potential winners are final and binding. The potential winners will be notified by email, mail or phone. The odds of winning a First or Second prize depend on the number of eligible entries received during the Promotion Period. Potential Grand Prize winner will have to complete a separate Declaration within five (5) days of notification in order to claim the Grand Prize. In the event that the Race is postponed or canceled for any reason or fans are not allowed to attend or participate in events at the Race, Sponsor will substitute any prize component for one of equal or greater value.

TWENTY-FIVE (25) SECOND PRIZES: Fan Gear package consisting of one (1) NASCAR Cup Series™Championship t-shirt; one (1) Coca-Cola NASCAR® officially licensed t-shirt; one (1) NASCAR® officially licensed logoed hat; and a Race Day Program. All details including sizes, styles, colors or components are determined by Sponsor, in its sole discretion. ARV: \$68.

<u>For All Prizes</u>: Winner shall not substitute, exchange or transfer any prize. Sponsor reserves the right to substitute any prize or prize component for one of equal or greater value.
