## Cinemark and Coca-Cola Refreshing Films Presents: Fan Favorite! Official Rules

## NO PURCHASE REQUIRED TO ENTER OR WIN.

- 1. Eligibility: The Cinemark and Coca-Cola Refreshing Films Presents: Fan Favorite! (the "Promotion") is open only to legal residents of the 50 U.S. (or D.C.) and Canada (excluding the Province of Quebec) who are 18 years of age or older at the time of entry. Then, follow the links and instructions to complete and submit the registration form including a valid email address. You will receive 1 Sweepstakes entry and will advance to the Instant Win Game page where you will receive 1 Instant Win Game play. You will be instantly notified if you are a potential winner of 1 of the Instant Win Game prizes. Please note, you may receive an on-screen notification that you are a potential Instant Win Game winner; this is subject to your eligibility verification and overall prize limitations set forth in these Official Rules.
